# What is Adult Family Care?

Adult Family Care also known as AFC, is a program for individuals that is 16 years or older with developmental, intellectual, physical, or mental disabilities or elderly person who cannot safely live alone. AFC Members live with trained, paid caregivers who provide daily care.

The Adult Family Care program, provides individuals with personal care assistance daily in a family setting rather than a nursing home or other residential facility. Caregivers are to provide 3 healthy meals with 2 healthy snacks daily, companionship, personal care assistance and 24-hours supervision. Caregivers and the member must live together.

### **Eligibility Requirements Potential AFC members should:**

- Have MassHealth Standard Health Insurance
- > Be at least 16 years of age or older
- > A licensed physician must order services
- Unable to live alone due to medical, physical, cognitive, or mental conditions
- Need daily assistance with one or more Activities of Daily Living (ADL), such as
  - o Bathing, Ambulation
  - $\circ$  Dressing (upper and lower)
  - o Eating
  - Toileting
  - Mobility, Transferring
- Member and Caregiver MUST live together
- Members cannot require continuous skilled nursing
- Caregivers cannot be the spouse or legal guardian of the members

# What it takes to be an AFC Caregiver?

#### A Caregiver:

- Can be a family member or nonfamily member
- <u>Cannot</u> be a spouse, a parent of a minor child or a legally responsible relative (e.g. Has legal guardianship)
- Has been approved by Rivers of Hope
  - Intake complete via phone or in person
  - Completed caregiver application
  - Agreed to have CORI and SORI check
  - Valid MA Driver's License
- Caregiver MUST be able to provide 24hour supervision



# The Benefits of AFC

The AFC provider (through the MassHealth

insurance coverage) is provided with:

- > Monthly stipend
  - The monthly stipend is based on 2 types of levels: Upon approval, families are made aware of the level they are approved for
- 2 weeks' respite for the caregiver per year.
- Monthly trainings during our visits by the Care Manager and/or RN, as needed, for additional supports
